Provider access statement

Introduction

This policy statement sets out the University's (Pre-Degree and Sixth Form) arrangements for managing the access of providers to students at the university for the purpose of giving them information about the providers education or training offer. This complies with the University's legal obligations under section 42B of the education act 1997.

Student entitlement

All students in years 1 and 2 are entitled to:

- To find out about technical education qualifications and apprenticeship opportunities, as part of a careers programme which provides information on the full range of education training options available at each transition point.
- To hear from a range of providers about opportunities they offer including technical education and apprenticeships- through career events such skills forward and the UCAS fair, and progression talks.
- To understand how to make applications for the full range of academic and technical courses available.

For students in year 2, especially those who have not yet decided on their next steps, there are more provider encounters available, which are optional for students to attend.

These provider encounters will be scheduled during the main timetable hours and the provider will be given a reasonable amount of time to, as a minimum:

- Share information about both the provider and the approved technical education qualification and apprenticeships that the provider offers.
- Explain what career routes those options could lead to.
- Provide insights into what it might be like to learn or train with that provider (including the opportunity to meet staff and students from the provider)
- Answer questions from students.

Meaningful provider encounters

One encounter is defined as one meeting/ session between students and one provider.
